PRIVACY DISCLOSURE**

Protecting your privacy is important to Pyramid Funds Corporation (a Broker-Dealer), Albany Pyramid Agency, Inc.(an Insurance Agency) and our employees. We want you to understand what information we collect and how we use it. In order to provide our customers with a broad range of financial products and services as effectively and conveniently as possible, we use technology to manage and maintain customer information. Accurate information lies at the heart of our pledge to provide these products and services, and we strive to protect your personal nonpublic information. The following policy serves as a standard for all Pyramid Funds Corporation and Albany Pyramid Agency, Inc. employees for collection, use, retention, and security of nonpublic personal information.

What Information We Collect:

We may collect “nonpublic personal information” about you from the following sources:

- Information we receive from you on applications or other account forms, such as name, address, date of birth, assets, income and investments, and social security numbers;
- Information about your transactions with us, our affiliates or others; such as the purchase and redemption of fund shares, balances and parties to the transactions from our affiliates and non-affiliates; and
- an address we have received from a third party when you have moved;
- Depending upon the product or services you are requesting, information we receive from medical providers to underwrite insurance, or others.

Sharing of Nonpublic Personal Information With Our Affiliates:

We consider your nonpublic personal information to be private and confidential. We may share this information with our affiliates so that they may process and service your transactions and to assist in processing requests you have authorized. We may disclose information due to legal proceedings, such as being subpoena for your records.

Sharing of Nonpublic Personal Information with Third Parties:

We will not share, distribute or sell nonpublic personal information about you or any former customer to any nonaffiliated third party except as required by law or permitted by laws enacted to protect your privacy. We do not sell lists of our customers, nor do we disclose customer information to marketing companies. If you close your accounts or we lose contact with you, we will continue to share information based on our current privacy policy and practices.

Our Security Practices:

We also take steps to safeguard customer information. We restrict access to your personal and account information to those employees who need to know that information to provide products or services to you. We maintain physical, electronic, and procedural safeguards that comply with federal standards to guard your nonpublic personal information.

In the case of an internal or external significant business disruption (SBD) where our office is unavailable for customer instructions, they may access their funds and securities by contacting the mutual fund companies or insurance companies directly.
